






A DUAL MODE OF ACTION



- ❖ 10 partners from 5 EU Countries (Austria, Germany, France, Switzerland, Portugal) and USA.
- ❖ SAGROPIA aims to introduce **thirteen biological and low-risk pesticides**, which shall replace "candidates for substitution" and active substances that are currently in use.
- Specifically targeting potato and sugar beet crops.
